## POL-3(5) HAWAII STATE ASSOCIATION OF COUNTIES (HSAC) (2009 LEGISLATIVE PACKAGE)

#### **DESCRIPTION:**

The Committee is in receipt of the following:

- Correspondence dated July 22, 2008, from Councilmember Joseph Pontanilla, transmitting correspondence dated July 1, 2008, from the HSAC President, requesting that proposals for the HSAC 2009 Legislative Package be submitted to the HSAC Executive Committee by October 1, 2008.
- Correspondence dated July 30, 2008, from Councilmember Joseph Pontanilla, transmitting a
  proposed State bill entitled "A BILL FOR AN ACT RELATING TO HOUSING" and a
  justification sheet for the bill. The purpose of the proposed State bill is to extend the 45-day
  window for a legislative body to approve, approve with modification, or disapprove an affordable
  housing project under Section 201H-38, Hawaii Revised Statutes, to 90 days.
- 3. Correspondence dated August 26, 2008, from Councilmember Danny A. Mateo, transmitting a proposed State bill entitled "A BILL FOR AN ACT RELATING TO TRAFFIC INFRACTIONS" and a justification sheet for the bill. The purpose of the proposed State bill is to require the State
