NOTICE IS HEREBY GIVEN that a public hearing will be held by the Council of the County of Maui, State of Hawaii, on Wednesday, May 14, 2008, beginning at 10:00 a.m., or soon thereafter, in the Council Chamber, 8th Floor, Kalana O Maui Building, 200 South High Street, Wailuku, Maui, Hawaii, for the purpose of receiving testimony, pursuant to Section 249-13, Hawaii Revised Statutes, and Section 3.24.030, Maui County Code, regarding the Motor Vehicle Weight Tax rates for Fiscal Year 2009:

1. \$0.0125 (one and one-fourth cents) per pound of net weight for passenger vehicles, and trucks and noncommercial vehicles not exceeding 6,500 pounds (no changes proposed).
2. \$0.02 (two cents) per pound of net weight for all other motor vehicles (no changes proposed).
3. Proposed minimum tax for any motor vehicle is \$12.00 (currently \$6.00). Proposed penalty for delinquent tax is \$8 for passenger vehicles or \$20 for other vehicles (currently 10% of tax due).

The rates are set forth in the Mayor's proposed budget (operating budget, Appendix "B") and are on file in the Office of the County Clerk, 7th Floor, Kalana O Maui Building, 200 South High Street, Wailuku, Maui, Hawaii, for use and examination by the public during regular business hours.

The Council shall receive testimony first from persons whose testimony forms are submitted prior to the convening of the public hearing. Initially, three (3) minutes will be granted, and at the discretion of the Council Chair, an additional minute may be granted to conclude the testimony; or an additional three (3) minutes will be granted to those who are unable to conclude their testimony, after all others desiring to speak have been heard.

Thereafter, persons whose testimony forms are submitted after the public hearing convenes will be allowed to present oral testimony for three (3) minutes. The Chair may grant an additional minute to conclude the testimony.

Written testimony must be submitted, e-mailed (county.clerk@mauicounty.us), or faxed (808-270-7171) to the Office of the County Clerk at least 24 hours prior to the public hearing so copies can be provided to the Council Members. If written testimony is submitted at the public hearing, 15 copies are requested.

Individuals who intend to attend the public hearing and who have disabilities requiring special assistance should call the Office of the County Clerk at 270-7748, at least three days in advance.
