POL-1(9) SETTLEMENT AUTHORIZATION OF CLAIMS AND LAWSUITS (ROBERT JARRETT, CLAIM NO. 2005-22)

DESCRIPTION: The Committee is in receipt of correspondence dated July 2, 2007, from the Department of the Corporation Counsel, requesting consideration of a proposed resolution entitled "AUTHORIZING SETTLEMENT OF CLAIM NO. 2005-22 OF ROBERT JARRETT", and transmitting a copy of the claim. The claim alleges damages and injuries suffered as a result of a motor vehicle collision. The purpose of the proposed resolution is to authorize settlement of the case for \$10,000.

STATUS: The Committee may consider whether to recommend adoption of the proposed resolution, with or without revisions. The Committee may also consider other related action.

POL-20 AFFORDABLE HOUSING FUND

DESCRIPTION:

The Committee is in receipt of the following:

1. County Communication No. 07-76, from Councilmember Michael J. Molina, transmitting a proposed bill relating to the affordable housing fund.
2. Correspondence dated July, 24, 2007, from the Policy Committee Chair, transmitting a revised draft bill entitled "A BILL FOR AN ORDINANCE AMENDING CHAPTER 3.35, MAUI COUNTY CODE, PERTAINING TO THE AFFORDABLE HOUSING FUND". The purpose of the revised draft bill is to amend Chapter 3.35 of the Maui County Code to meet the new requirements set forth in Section 9-20 of the Maui County Charter.

STATUS:
