SETTLEMENT AUTHORIZATION OF CLAIMS AND LAWSUITS (HANOHANO, LLC V. COUNTY OF MAUI, ET AL., CIVIL NO. 06-1-0148(1))

DESCRIPTION:

The Committee is in receipt of correspondence dated April 9, 2008, from the Department of the Corporation Counsel, requesting consideration of a proposed resolution entitled "AUTHORIZING SETTLEMENT OF HANOHANO, LLC V. COUNTY OF MAUI, ET AL., CIVIL NO. 06-1-0148(1)". The complaint seeks declaratory, injunctive, and other relief stemming from a County zoning decision affecting lands comprising the Pukalani residential community, including two parcels of land owned by Plaintiff Hanohano, LLC, consisting of approximately 28.695 acres situated at Keahua, Kula, Maui, Hawaii. The purpose of the proposed resolution is to authorize settlement of the case.

STATUS:

The Committee may consider whether to recommend adoption of the proposed resolution, with or without revisions. The Committee may also consider other related action.
