Chair and Members:

Your Policy Committee, having met on August 14, 2007, makes reference to County Communication No. 07-222, from Councilmember Danny A. Mateo, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING SECTION 22.04A.070, MAUI COUNTY CODE, RELATING TO THE KULA AGRICULTURAL PARK COMMITTEE".

The purpose of the proposed bill is to clarify the terms of appointments for the Council's and Mayor's representatives to the Kula Agricultural Park Committee.

At its meeting, your Committee met with two Deputy Corporation Counsel.

There was no public testimony.

Your Committee noted that the amendment would clarify that the term of appointment for the Council's representative to the Kula Agricultural Park Committee would be concurrent with the Council member's term of office, and the term of appointment for the Mayor's representative to the Committee would be concurrent with the Mayor's term of office.

Your Committee voted to recommend passage of the proposed bill and filing of the communication.

Your Policy Committee RECOMMENDS the following:

1. That Bill No. _____ (2007), attached hereto, entitled "A BILL FOR AN ORDINANCE AMENDING SECTION 22.04A.070, MAUI COUNTY CODE, RELATING TO THE KULA AGRICULTURAL PARK COMMITTEE", be PASSED ON FIRST READING and be ORDERED TO PRINT; and







BILL NO. _____ (2007)

A BILL FOR AN ORDINANCE AMENDING SECTION 22.04A.070, MAUI COUNTY CODE, RELATING TO THE KULA AGRICULTURAL PARK COMMITTEE

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Section 22.04A.070, Maui County Code, is amended by amending subsection B to read as follows:

“B. The representative from the council shall be appointed by the council for a [two-year] term concurrent with the council member’s term of office. The representative from the office of the mayor shall be appointed by the mayor without approval by the council for a term concurrent with the mayor’s term of office. The remaining nine members of the committee shall be nominated by the mayor, approved by the council, and [shall] serve staggered terms of five years.”

SECTION 2. Material to be repealed is bracketed. New material is underscored. In printing this bill, the County Clerk need not include the brackets, the bracketed material, or the underscoring.

SECTION 3. This ordinance shall take effect upon its approval. The term of the Council’s representative on the Kula Agricultural Park Committee as of the effective date of this ordinance shall be concurrent with the Council member’s term of office. The term of the Mayor’s representative on the Kula Agricultural Park Committee as of the effective date of this ordinance shall be concurrent with the Mayor’s term of office.
