**PROPOSED BUDGET FOR FISCAL YEAR 2008 FOR THE COUNTY OF MAUI**

**DESCRIPTION:** The Committee is in receipt of the following:

1. County Communication No. 07-29, from Councilmember Joseph Pontanilla, relating to the matter of the proposed budget for Fiscal Year (FY) 2008.
2. County Communication No. 07-87, from the Acting Corporation Counsel and the Acting Prosecuting Attorney, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING SECTION 2.44.015, MAUI COUNTY CODE, RELATING TO SALARIES OF

DEPUTIES CORPORATION COUNSEL AND DEPUTIES PROSECUTING ATTORNEY". The purpose of the proposed bill is to amend the salaries of deputies in the Department of the Corporation Counsel and the Department of the Prosecuting Attorney.

3. County Communication No. 07-109, from the Mayor, relating to the proposed budget for FY 2008 for the County of Maui. Included in the Mayor's transmittal are the following:
  - a. A proposed bill entitled "A BILL FOR AN ORDINANCE RELATING TO THE OPERATING BUDGET FOR THE COUNTY OF MAUI FOR THE FISCAL YEAR JULY 1, 2007 TO JUNE 30, 2008". The purpose of the proposed bill is to appropriate estimated revenues for the operating and capital improvement budget. Incorporated within the proposed bill are Appendix A, which lists Grant Revenues and Special Purpose Revenues, and Appendix B, which is the Schedule of Rates, Fees, and Assessments.
  - b. A proposed bill entitled "A BILL FOR AN ORDINANCE RELATING TO THE CAPITAL PROGRAM FOR THE FISCAL YEAR ENDING JUNE 30, 2008". The purpose of the proposed bill is to set forth the Capital Program for FY 2008 through 2013. Incorporated within the proposed bill are Appendix A, a report entitled "COUNTY OF MAUI, CAPITAL IMPROVEMENT PROJECTS REPORT, AS OF DECEMBER 31, 2006", which lists all pending capital improvement projects and appropriations as of December 31, 2006; and Appendix B, which is the proposed Capital Improvement Program for FY 2008 through 2013.
  - c. A proposed bill to authorize the issuance of general obligation bonds for various capital improvement projects.
  - d. A proposed bill to reauthorize the use of lapsed bond proceeds for various capital improvement projects.
  - e. A proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING SECTION 2.68.060, MAUI COUNTY CODE, PERTAINING TO VOTER REGISTRATION COMPUTER TAPES". The purpose of the proposed bill is to allow the rental charge and deposit amount for the use of voter registration computer tapes to be set forth in the annual budget.
  - f. A proposed bill to amend Section 6.16.080, Maui County Code, to allow the charges to capture, impound, and keep an animal and all pound fees to be set forth in the annual budget.
  - g. A proposed bill to amend Chapter 13.16, Maui County Code, to add definitions for "Daily rate" and "Twilight rate" and revise the definition of "Playing fee" for the Waiehu Municipal Golf Course.
  - h. A proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING SECTION 18.20.250, MAUI COUNTY CODE, PERTAINING TO SUBDIVISION INSPECTION FEES". The purpose of the proposed bill is to allow the amount of the fee for inspecting construction improvements on Saturdays, Sundays, and holidays to be set forth in the annual budget.
  - i. A proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING SECTION 16.20A.200, MAUI COUNTY CODE, PERTAINING TO MISCELLANEOUS PLUMBING INSTALLATION INSPECTIONS". The purpose of the proposed bill is to allow the amount of the miscellaneous plumbing installation inspection fee to be set forth in the annual budget.
  - j. Booklets entitled "FISCAL YEAR 2008 BUDGET PROPOSAL" (Program Budget) and "FISCAL YEAR 2008 PROPOSED BUDGET DETAILS" (Budget Details).
4. Correspondence dated April 3, 2007, from the Department of the Corporation Counsel, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING TITLE 3, MAUI COUNTY CODE, TO ESTABLISH A POST-EMPLOYMENT OBLIGATIONS FUND". The purpose of the proposed bill is to establish a post-employment obligations fund for the purpose of funding the County's financial liabilities for post-employment benefits accrued under the Employees' Retirement System of the State of Hawaii and the Hawaii Employer-Union Health Benefits Trust Fund.
5. Correspondence dated April 10, 2007, from the Department of the Corporation Counsel, transmitting the following:
  - a. A revised proposed bill entitled "A BILL FOR AN ORDINANCE AUTHORIZING THE ISSUANCE OF THIRTY FOUR MILLION SEVEN HUNDRED FIFTY THOUSAND

DOLLARS (\$34,750,000) AGGREGATE PRINCIPAL AMOUNT OF GENERAL OBLIGATION BONDS OF THE COUNTY OF MAUI FOR THE PURPOSE OF PROVIDING FUNDS TO PAY ALL OR A PART OF THE COST OF APPROPRIATIONS FOR PUBLIC IMPROVEMENTS OF AND FOR THE COUNTY OF MAUI; FIXING THE FORM, DENOMINATIONS AND CERTAIN OTHER FEATURES OF SUCH BONDS AND PROVIDING FOR THEIR SALE; AUTHORIZING THE DIRECTOR OF FINANCE TO DETERMINE CERTAIN DETAILS OF THE BONDS; AUTHORIZING THE ISSUANCE AND SALE OF A LIKE PRINCIPAL AMOUNT OF GENERAL OBLIGATION BOND ANTICIPATION NOTES IN ANTICIPATION OF THE ISSUANCE AND SALE OF SUCH BONDS; AND PROVIDING FOR OTHER ACTIONS RELATED TO THE ISSUANCE, SALE AND DELIVERY OF SAID BONDS". The purpose of the revised proposed bill is to authorize the issuance of general obligation bonds for various capital improvement projects.

- b. A revised proposed bill entitled "A BILL FOR AN ORDINANCE DETERMINING THAT PART OF THE PROCEEDS OF GENERAL OBLIGATION BONDS OF THE COUNTY OF MAUI HERETOFORE ISSUED IS IN EXCESS OF THE AMOUNTS REQUIRED FOR THE PURPOSES FOR WHICH SUCH BONDS WERE INITIALLY ISSUED, OR MAY OR SHOULD NOT BE APPLIED TO THOSE PURPOSES, AND DIRECTING SUCH PROCEEDS TO OTHER PUBLIC IMPROVEMENTS OR AUTHORIZED PURPOSES OF THE COUNTY OF MAUI". The purpose of the revised proposed bill is to reauthorize the use of lapsed bond proceeds for various capital improvement projects.
  - c. A revised proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING SECTION 6.16.080, MAUI COUNTY CODE, PERTAINING TO REDEMPTION OF IMPOUNDED ANIMALS". The purpose of the revised proposed bill is to allow the charges to capture, impound, and keep an animal and all pound fees to be set forth in the annual budget.
  - d. A revised proposed bill entitled "A BILL FOR AN ORDINANCE TO AMEND CHAPTER 13.16, MAUI COUNTY CODE, RELATING TO WAIEHU MUNICIPAL GOLF COURSE". The purpose of the revised proposed bill is to add definitions for "Daily rate" and Twilight rate" and revise the definition of "Playing fee" for the Waiehu Municipal Golf Course.
6. Correspondence dated April 11, 2007, from the Department of the Corporation Counsel, transmitting the following:
    - a. A proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING SECTION 3.30.020, MAUI COUNTY CODE, PERTAINING TO THE FIRST-TIME HOME BUYERS' REVOLVING FUND". The purpose of the proposed bill is to repeal the provision that states that any balance in the fund at the end of the fiscal year shall not lapse.
    - b. A proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING SECTION 16.20A.130, MAUI COUNTY CODE, PERTAINING TO THE PLUMBING CODE". The purpose of the proposed bill is to correct a conflict pertaining to the fee for a new plumbing permit following expiration of a permit.
  7. Correspondence dated April 13, 2007, from the Department of the Corporation Counsel, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING CHAPTER 3.48, MAUI COUNTY CODE, PERTAINING TO THE REAL PROPERTY TAX EXEMPTIONS FOR DEPLOYED ACTIVE-DUTY MILITARY PERSONNEL". The purpose of the proposed bill is to establish a real property tax exemption for deployed active-duty military personnel.
  8. Correspondence dated April 19, 2007, from the Department of the Corporation Counsel, transmitting the following:
    - a. A proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING SECTION 3.48.450, MAUI COUNTY CODE, PERTAINING TO REAL PROPERTY TAX HOME EXEMPTION". The purpose of the proposed bill is to amend the home exemption.
    - b. A proposed resolution entitled "ADOPTING THE FUEL TAX RATES FOR THE COUNTY OF MAUI, EFFECTIVE JULY 1, 2007". The purpose of the proposed resolution is to adopt fuel tax rates in accordance with Section 243-5, Hawaii Revised Statutes, and Section 3.20.010, Maui County Code.

9. Correspondence dated April 19, 2007, from the Director of Council Services, transmitting a revised proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING SECTION 2.08.060, MAUI COUNTY CODE, RELATING TO SALARIES OF PERSONNEL IN THE OFFICE OF COUNCIL SERVICES AND OTHER COUNCIL STAFF". The purpose of the proposed bill is to amend the salaries of positions in the Office of Council Services.
