Chair and Members:

Your Budget and Finance Committee, having met on September 17, 2007, makes reference to Contract No. G2340, between the County of Maui and The Lahaina Restoration Foundation, relating to the Lahaina Transportation Workshop.

Your Committee notes that the purpose of Contract No. G2340 is to grant \$50,000 to The Lahaina Restoration Foundation to offset operational costs for the Lahaina Transportation Workshop. Your Committee further notes that The Lahaina Restoration Foundation is a Hawaii non-profit organization, whose purpose is to cooperate with all community-oriented interests in an effort to restore, maintain, and preserve the physical and cultural legacies and history of the first capital of the Kingdom of Hawaii.

Your Committee further notes that the Lahaina Transportation Workshop is a multi-day public event that will bring various parties together to plan and design major infrastructure improvements for the Lahaina Community Plan area.

Your Committee notes that the contract was referred because of concerns regarding the source of funding for this contract.

At its meeting, your Committee met with the Budget Director; the Director of Finance; the Deputy Director of Transportation; an Administrative Assistant, Department of Planning; and a Deputy Corporation Counsel.

There was no public testimony.

Your Committee noted that the Department of Planning confirmed that the funds for this grant was not from appropriations for the General Plan Update.
