Chair and Members:

Your Budget and Finance Committee, having met on February 21, 2008, makes reference to County Communication No. 08-37, from the Budget Director, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING APPENDIX A OF THE FISCAL YEAR 2008 BUDGET FOR THE COUNTY OF MAUI AS IT PERTAINS TO THE DEPARTMENT OF PLANNING".

The purpose of the proposed bill is to amend Appendix A, Part I, of the Fiscal Year 2008 Budget, relating to grant revenues, as it pertains to the Department of Planning by appropriating \$50,000 for the "Certified Local Government (CLG) Program".

At its meeting, your Committee met with the Budget Director, the Deputy Planning Director, and the First Deputy Corporation Counsel.

There was no public testimony.

The Deputy Director stated that the Hawaii State Historic Preservation Division, Department of Land and Natural Resources, selected the Department of Planning's proposal to expand the scope of the County's Cultural Resources Management Plan Update through a competitive bid process. The Deputy Director further stated that the \$50,000 State grant will be used for the following: (1) a photographic inventory of National Register sites in Maui County; (2) a cultural resources survey update of Lahaina town; and (3) a records catalogue for the Wo Hing Society relating to Lahaina town.

The Deputy Director explained that the Department of Planning intends to contract a third party for the Cultural Resources Management Plan Update, who would also perform the work to be done under this State grant.

Your Committee voted to recommend passage of the proposed bill and filing of the communication.
