**HRS CHAPTER 201H AFFORDABLE HOUSING PROJECTS (KULA RIDGE RESIDENTIAL WORKFORCE HOUSING SUBDIVISION)**

**DESCRIPTION:**

The Committee is in receipt of correspondence dated October 6, 2008, from the Director of Housing and Human Concerns, transmitting the following:

1. An application for the development of the proposed Kula Ridge Residential Workforce Housing Subdivision in Kula, Maui, Hawaii, TMK: (2) 2-3-01:174, pursuant to Section 201H-38, Hawaii Revised Statutes (HRS). The proposed project consists of approximately 116 improved lots with approximately 70 lots set aside for workforce housing or affordable house-lot packages. Affordable house-lot units are proposed to be integrated with market priced lots;
2. A proposed resolution entitled "APPROVING THE KULA RIDGE RESIDENTIAL WORKFORCE HOUSING SUBDIVISION PURSUANT TO SECTION 201H-38, HAWAII REVISED STATUTES". The purpose of the proposed resolution is to approve the proposed project with various exemptions from requirements contained in the Maui County Code and Hawaii Administrative Rules relating to planning, zoning, construction standards for subdivisions, the development and improvement of land, and the construction of dwelling units;

3. A proposed resolution entitled "APPROVING WITH MODIFICATION THE KULA RIDGE RESIDENTIAL WORKFORCE HOUSING SUBDIVISION PURSUANT TO SECTION 201H-38, HAWAII REVISED STATUTES". The purpose of the proposed resolution is to approve the proposed project with the modifications in Exhibit "1" and various exemptions from requirements contained in the Maui County Code and Hawaii Administrative Rules relating to planning, zoning, construction standards for subdivisions, the development and improvement of land, and the construction of dwelling units; and
4. A proposed resolution entitled "DISAPPROVING THE KULA RIDGE RESIDENTIAL WORKFORCE HOUSING SUBDIVISION PURSUANT TO SECTION 201H-38, HAWAII REVISED STATUTES". The purpose of the proposed resolution is to disapprove the proposed project.

**STATUS:** Pursuant to Section 201H-38, HRS, the Council shall approve, approve with modification, or disapprove the proposed project by November 20, 2008, or it will be deemed approved. The Committee may consider whether to recommend adoption of a proposed resolution, with or without revisions. The Committee may also consider other related action.
