**PW-38 PEDESTRIAN SAFETY AT THE INTERSECTION OF VINEYARD STREET AND MARKET STREET (WAILUKU)**

**DESCRIPTION:** The Committee is in receipt of County Communication No. 05-280, from Councilmember Joseph Pontanilla, transmitting correspondence dated August 2, 2005 from Mona Harris regarding the safety of persons crossing the street at the intersection of Vineyard Street and Market Street in Wailuku.
