### **GRANT OF NON-EXCLUSIVE EASEMENT TO THE WILLIAM H. MCFARLAND AND ROSE-MARIE MCFARLAND FAMILY TRUST, FOR PRIVATE SEWER LINE PURPOSES (LAHAINA)**

**DESCRIPTION:**

The Committee is in receipt of County Communication No. 06-252, from the Director of Public Works and Environmental Management, transmitting a proposed resolution entitled "AUTHORIZING THE GRANTING OF NON-EXCLUSIVE EASEMENT ON COUNTY OF MAUI REAL PROPERTY SITUATED AT WAHIKULI, LAHAINA, MAUI, HAWAII, TO THE WILLIAM H. MCFARLAND AND ROSE-MARIE MCFARLAND FAMILY TRUST, FOR PRIVATE SEWER LINE PURPOSES". The purpose of the proposed resolution is to grant a non-exclusive easement of approximately 2,326 square feet to the William H. McFarland and Rose-Marie McFarland Family Trust to provide a private sewer line on property located at TMK: (2) 4-5-13:003 in Lahaina, Maui.
