DESIGNATING THE DIRECTOR OF PUBLIC WORKS AND ENVIRONMENTAL MANAGEMENT AS THE AUTHORIZED REPRESENTATIVE TO GRANT PERMISSION TO INSTALL UTILITY POLES

DESCRIPTION:

The Committee is in receipt of County Communication No. 06-243, from Council Chair G. Riki Hokama, transmitting a proposed resolution entitled "DESIGNATING THE DIRECTOR OF PUBLIC WORKS AND ENVIRONMENTAL MANAGEMENT AS THE AUTHORIZED REPRESENTATIVE TO GRANT PERMISSION TO INSTALL UTILITY POLES PURSUANT TO CHAPTER 12.16, MAUI COUNTY CODE". The purpose of the proposed resolution is to renew the Council's authorization of the Director of Public Works and Environmental Management to approve routine installation of utility poles in cases where the number of poles to be installed does not exceed six, and the height of such poles does not exceed the height of existing poles.

PW-42 DOWNHILL BICYCLE TOURS

DESCRIPTION: The Committee is in receipt of the following:

1. County Communication No. 05-318, from Councilmember Michael J. Molina, transmitting correspondence from Jimmy Muschietti, expressing concerns relating to downhill bicycle tours, specifically the lack of enforcement of traffic laws.
2. Correspondence dated October 24, 2006, from the Department of the Corporation Counsel, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING CHAPTER 5.22, MAUI COUNTY CODE, RELATING TO BICYCLE TOUR BUSINESS". The purpose of the proposed bill is to increase the current liability insurance requirements needed in order to obtain a license to operate a bicycle tour business.

STATUS: The Committee may consider whether to recommend passage of the proposed bill on first reading, with or without revisions. The Committee may also consider the filing of County Communication No. 05-318 and other related action.

PW-18 OUTDOOR LIGHTING

DESCRIPTION: The Committee is in receipt of the following:

1. County Communication No. 00-125, from a former Council Chair, transmitting correspondence from a constituent relating to the abatement of light trespass.
2. Correspondence dated November 2, 2006, from the Chair of the Committee, transmitting a draft bill entitled "A BILL FOR AN ORDINANCE AMENDING TITLE 20, MAUI COUNTY CODE, BY ADDING A NEW CHAPTER RELATING TO OUTDOOR LIGHTING". The purpose of the draft bill is to establish outdoor lighting standards, reduce light pollution, and enhance the night sky for astronomical research and preservation of wildlife.

STATUS: The Committee may consider whether to recommend passage of the draft bill on first reading, with or without revisions. The Committee may consider the filing of County Communication No. 00-125 and other related action.
