Chair and Members:

Your Public Works Committee, having met on June 5, 2006, makes reference to County Communication No. 06-82, from the Director of Public Works and Environmental Management, transmitting a proposed resolution entitled "ACCEPTING DEDICATION OF ROAD WIDENING LOTS FOR THE ALAE 3 AND 4 HOMESTEADS, PURSUANT TO SECTION 3.44.015, MAUI COUNTY CODE".

The purpose of the proposed resolution is to accept the dedication of road widening Lots 14-F and 14-G along Naalae Road, Kula, Maui, identified as TMK: (2) 2-2-15:003, for public purposes.

At its meeting, your Committee met with the Director of Public Works and Environmental Management and a Deputy Corporation Counsel.

There was no public testimony.

The Director informed your Committee that road widening Lots 14-F and 14-G are part of a five-lot subdivision known as the Alae 3 and 4 Homesteads. Lot 14-F is a triangular parcel consisting of 574 square feet, and Lot 14-G is a triangular parcel consisting of 537 square feet. The subdivision was granted final approval on February 23, 2006. Required improvements were inspected and approved by the Department on February 24, 2006, as well as by the Department of Water Supply on February 10, 2006.

Your Committee voted to recommend adoption of the proposed resolution and filing of the communication.
