Chair and Members:

Your Public Works Committee, having met on October 16, 2006, makes reference to County Communication No. 06-209, from the Director of Public Works and Environmental Management, transmitting a proposed resolution entitled "ACCEPTING DEDICATION OF A ROAD WIDENING LOT FOR THE ROMERO SUBDIVISION, PURSUANT TO SECTION 3.44.015, MAUI COUNTY CODE".

The purpose of the proposed resolution is to accept road widening Lot 2 located at TMK: (2) 3-4-08:023 (portion) along Wells Street, Wailuku, Maui, for public purposes.

Your Committee notes that pursuant to Section 3.44.015(C), Maui County Code (MCC), the Council "may accept gifts or donations of real property or any interest in real property by the passage of a resolution, approved by a majority of its members".

By correspondence dated October 9, 2006, the Chair of your Committee requested that the Department of the Corporation Counsel make nonsubstantive revisions to number the pages of the Exhibit attached to the proposed resolution.

By correspondence dated October 11, 2006, the Department of the Corporation Counsel transmitted a revised proposed resolution, entitled "ACCEPTING DEDICATION OF A ROAD WIDENING LOT FOR THE ROMERO SUBDIVISION, PURSUANT TO SECTION 3.44.015, MAUI COUNTY CODE", incorporating the requested revisions.

At its meeting, your Committee met with the Director of Public Works and Environmental Management and a Deputy Corporation Counsel.

There was no public testimony.

The Director provided your Committee with background information regarding the subject lot. He noted that Lot 2 consists of 711 square feet. He further noted that the subdivision was granted final subdivision approval on November 30, 2004.

The Director stated that although correspondence dated July 25, 2006, from the Department of Public Works and Environmental Management to the Council, indicated that "improvements are complete and were approved by the Department of Public Works and Environmental Management on July 25, 2006", no roadway improvements are necessary because the subdivider is dedicating a road widening lot to the County. The Director further stated that Section 18.20.040(A), MCC, exempts a subdivider from providing improvements for subdivisions creating only road widening lots.

Your Committee voted to recommend adoption of the revised proposed resolution and filing of the communication.

Your Committee is in receipt of a further revised resolution, from the Department of the Corporation Counsel, correcting a reference to the location of the property in the attached Warranty Deed, from Wailuku to Makawao.

Your Public Works Committee **RECOMMENDS** the following:

1. That Resolution No. _____, as revised herein and attached hereto, entitled "ACCEPTING DEDICATION OF A ROAD WIDENING LOT FOR THE ROMERO SUBDIVISION, PURSUANT TO SECTION 3.44.015, MAUI COUNTY CODE", be ADOPTED; and
2. That County Communication No. 06-209 be FILED.
