DONATION FROM LAUNIUPOKO ASSOCIATES, LLC TO THE DEPARTMENT OF PARKS AND RECREATION

DESCRIPTION:

**PED-21 REQUEST FOR WAIVER OF PARK DEDICATION REQUIREMENTS
FOR THE LOKAHI KUHUA SUBDIVISION (LAHAINA)**

DESCRIPTION: The Committee is in receipt of County Communication No. 05-350, from the Director of Parks and Recreation, transmitting a proposed resolution entitled “APPROVING THE WAIVER OF CERTAIN PARK REQUIREMENTS FOR A PRIVATELY OWNED AND MAINTAINED PARK PURSUANT TO SECTION 18.16.320, MAUI COUNTY CODE, FOR THE LOKAHI KUHUA SUBDIVISION, LAHAINA, MAUI, HAWAII”. The purpose of the proposed resolution is to approve the waiver of the requirement to provide comfort stations and parking for a privately owned and maintained park, comprising approximately 4,308 square feet in the Lokahi Kuhua Subdivision in Lahaina (TMK: (2) 4-5-23:070 and 072).
