**PED-21 REQUEST FOR WAIVER OF PARK DEDICATION REQUIREMENTS
FOR THE LOKAHI KUHUA SUBDIVISION (LAHAINA)**

DESCRIPTION: The Committee is in receipt of County Communication No. 05-350, from the Director of Parks and Recreation, transmitting a proposed resolution entitled “APPROVING THE WAIVER OF CERTAIN PARK REQUIREMENTS FOR A PRIVATELY OWNED AND MAINTAINED PARK PURSUANT TO SECTION 18.16.320, MAUI COUNTY CODE, FOR THE LOKAHI KUHUA SUBDIVISION, LAHAINA, MAUI, HAWAII”.
