PED-36 ACCEPTING LAND DEDICATION FOR PARK AND PLAYGROUND PURPOSES AND WAIVING CERTAIN PARK DEDICATION REQUIREMENTS FOR THE WAILUKU COUNTRY ESTATES SUBDIVISION (WAILUKU)

DESCRIPTION: The Committee is in receipt of County Communication No. 06-193, from the Director of Parks and Recreation, transmitting a proposed resolution entitled “ACCEPTING LAND DEDICATED FOR PARK AND PLAYGROUND PURPOSES AND WAIVER OF COMFORT STATION PURSUANT TO SECTION 18.16.320, MAUI COUNTY CODE”. The purpose of the proposed resolution is to: 1) accept the dedication of a park located in the Wailuku Country Estates Subdivision, Wailuku, Maui, comprised of approximately 98,395 square feet (2.263 acres), and identified as TMK: (2) 3-3-02:portion of 001 (Subdivision File No. 3.1723); and 2) approve the waiver of the requirements to provide comfort stations in the subject park.

STATUS: The Committee will view the property and the surrounding area. No legislative action will be taken.

PED-40 ACCEPTING LAND DEDICATION FOR PARK AND PLAYGROUND PURPOSES AND WAIVING CERTAIN PARK DEDICATION REQUIREMENTS FOR PHASE I OF THE MAUI LANI SUBDIVISION (KAHULUI)

DESCRIPTION: The Committee is in receipt of County Communication No. 06-237, from the Director of Parks and Recreation, transmitting a proposed resolution entitled “ACCEPTING LAND DEDICATED FOR PARK AND PLAYGROUND PURPOSES AND WAIVER OF COMFORT STATION AND PARKING AREAS PURSUANT TO SECTION 18.16.320, MAUI COUNTY CODE”. The purpose of the proposed resolution is to: 1) accept the dedication of a park located in Phase I of the Maui Lani Subdivision, Kahului, Maui, comprised of approximately 78,308 square feet (1.798 acres), and identified as TMK: (2) 3-8-07:portion of 121 (Subdivision File No. 3.1678); and 2) approve the waiver of the requirements to provide comfort stations and parking in the subject park.
