**COW-55            OPPOSING COMMENCEMENT OF HAWAII SUPERFERRY AT  
KAHULUI HARBOR**

**DESCRIPTION:**    The Committee is in receipt of County Communication No. 06-176, from the Council Chair, transmitting a proposed resolution entitled "OPPOSING THE PROPOSED COMMENCEMENT OF SERVICE OF THE HAWAII SUPERFERRY AT KAHULUI HARBOR". The purpose of the proposed resolution is to oppose the commencement of operation of the Hawaii Superferry at the Kahului Harbor in April 2007, pending an update of the Harbor Master Plan, preparation of an Environmental Impact Statement, and construction of necessary improvements.
