COW-1(45) SETTLEMENT AUTHORIZATION OF CLAIMS AND LAWSUITS (HOA LE, M.D. AND JENNIFER YANG, M.D. V. THE KEA LANI HOTEL CORPORATION, D/B/A/ THE KEA LANI HOTEL, A HAWAII PROFIT CORPORATION, ET AL., CIVIL NO. 04-1-0124(2))

DESCRIPTION: The Committee is in receipt of correspondence dated December 8, 2006, from the Council Chair, transmitting a copy of correspondence dated December 7, 2006, from the Department of the Corporation Counsel, requesting consideration of a proposed resolution entitled "AUTHORIZING SETTLEMENT OF HOA LE, M.D. AND JENNIFER YANG, M.D. V. THE KEA LANI HOTEL CORPORATION, D/B/A/ THE KEA LANI HOTEL, A HAWAII PROFIT CORPORATION, ET AL. CIVIL NO. 04-1-0124(2)", and transmitting a copy of the complaint. The complaint alleges damages due to injuries sustained at Kalama Park, Kihei. The purpose of the proposed resolution is to authorize settlement of the case for \$100,000.
