Chair and Members:

Your Committee of the Whole, having met on August 15, 2006, makes reference to County Communication No. 05-25, from the Council Chair, regarding proposed contracts for special counsel.

Your Committee is in receipt of correspondence dated August 4, 2006, from the Department of the Corporation Counsel, requesting consideration of a proposed resolution entitled "AUTHORIZING ADDITIONAL COMPENSATION FOR SPECIAL COUNSEL MARR HIPPI JONES & WANG, IN TRINIDAD K. ALCONCEL, ET AL. VS. COUNTY OF MAUI, CIVIL NO. CV05-00280 SPK BMK". The purpose of the proposed resolution is to authorize \$85,000 in additional compensation for Marr Hipp Jones & Wang as special counsel in the case for a total compensation of \$125,000.

Your Committee notes that this case includes allegations of violations of the Fair Labor Standards Act.

Your Committee further notes that the Council authorized initial compensation of \$40,000 by Resolution No. 05-147.

At its meeting, your Committee met with the Chief of Police; a Deputy Corporation Counsel; and Steven Nakashima, Esq. of Marr Hipp Jones & Wang.

There was no public testimony. The Deputy Corporation Counsel provided a brief overview of the case and noted that 84 plaintiffs have been added to the case. She requested the opportunity to discuss the matter in an executive meeting.

Your Committee voted to convene an executive meeting for the purpose of consulting with legal counsel on liability issues in the matter, pursuant to Section 92-5(a)(4), Hawaii Revised Statutes.

At its executive meeting, your Committee met with the Chief of Police; a Deputy Corporation Counsel; and Steven Nakashima, Esq. of Marr Hipp Jones & Wang.
