BF-86 PROPOSED CHARTER AMENDMENT (ACQUISITION-BASED TAX REFORM)

DESCRIPTION: The Committee is in receipt of a County Communication No. 06-146, from Tony Fisher, Vice-Chairman, Committee For More Equitable Taxation (COMET), submitting a proposed Charter amendment relating to acquisition-based tax reform. COMET requests that the County Council adopt a resolution to initiate an amendment to the Revised Charter of the County of Maui (1983), as amended (Charter), to establish an acquisition-based real property tax system.

STATUS: The Committee may discuss COMET's proposed Charter amendment. No legislative action will be taken. A charter amendment is required to be in the form of a resolution, but a proposed resolution is not pending before the Committee for appropriate public notice.
