REAL PROPERTY TAX HOMEOWNER EXEMPTION

DESCRIPTION:

The Committee is in receipt of the following:

1. County Communication No. 06-184, from Councilmember Dain P. Kane, transmitting a draft bill to permanently establish a \$300,000 homeowner exemption.
2. Correspondence dated August 7, 2006, from the First Deputy Corporation Counsel, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING SECTION 3.48.450, MAUI COUNTY CODE, PERTAINING TO REAL PROPERTY TAX HOME EXEMPTION". The proposed bill incorporates nonsubstantive changes to the draft bill.

STATUS:
