Your Public Works and Traffic Committee, having met on January 23, 2003, makes reference to County Communication No. 02-244, from the Director of Public Works and Waste Management, transmitting a proposed resolution entitled "ACCEPTING DEDICATION OF A ROAD WIDENING LOT FOR THE HUNTER SUBDIVISION, PURSUANT TO SECTION 3.44.015, MAUI COUNTY CODE".

The purpose of the proposed resolution is to accept the dedication of road widening Lot 1-G along Kokomo Road in Makawao, TMK: (2)-2-7-003:019.

At its meeting of January 10, 2003, the Council referred County Communication No. 02-244 to your Public Works and Traffic Committee (County Communication No. 03-12).

At its meeting, your Committee met with the Director of Public Works and Environmental Management and a Deputy Corporation Counsel.

The Director provided your Committee with an overview of the matter. He stated that the road widening lot consists of 1,016 square feet along Kokomo Road in Makawao. He further noted that the road widening lot is being dedicated to the County to comply with subdivision requirements, and all necessary improvements have been made to the property.

Your Committee voted to recommend the adoption of the proposed resolution and the filing of the communication.
