Chair and Members:

Your Public Works and Traffic Committee, having met on July 31, 2003, makes reference to County Communication No. 03-182, from the Director of Public Works and Environmental Management, transmitting a proposed resolution entitled "ACCEPTING DEDICATION OF A DRAINAGE AND SEWER LOT FOR THE PIILANI VILLAGE – PHASE II, PURSUANT TO SECTION 3.44.015, MAUI COUNTY CODE".

The purpose of the proposed resolution is to accept the dedication of sewer line and drainage easement Lot 118, in connection with the Piilani Village Phase II subdivision, Kihei, TMK No. (2) 2-2-026:118.

At its meeting, your Committee met with the Director of Public Works and Environmental Management and a Deputy Corporation Counsel.

Your Committee received maps and aerial photographs delineating the proposed drainage and sewer lot dedication, from Clifford Mukai of Warren Unemori Engineering, Inc.

The Director stated that the proposed drainage and sewer lot is a relatively small area, consisting of 2,316 square feet, located on the western portion of the subdivision. He further stated that the lot is being dedicated to the County to comply with subdivision requirements, and all necessary improvements have been made to the property.

Your Committee voted to recommend passage of the proposed resolution, and filing of the communication.
