Chair and Members:

Your Public Works and Traffic Committee, having met on September 18, 2003, makes reference to County Communication No. 03-215, from the Director of Public Works and Environmental Management, transmitting a proposed resolution entitled "ACCEPTING DEDICATION OF A ROAD WIDENING LOT FOR THE VINEYARD STREET ROAD WIDENING SUBDIVISION, PURSUANT TO SECTION 3.44.015, MAUI COUNTY CODE".

The purpose of the proposed resolution is to accept the dedication of road widening Lot 2, located at the northwest corner of the intersection of Vineyard and North Market Streets in Wailuku, Tax Map Key (TMK) No. (2) 3-4-017:027.

At its meeting, your Committee met with the Director of Public Works and Environmental Management and a Deputy Corporation Counsel.

The Director provided your Committee with an overview of the matter. He stated that the proposed resolution will accept the dedication of road widening Lot 2 consisting of 861 square feet along Vineyard Street in Wailuku.

In response to an inquiry by your Committee, the Director stated that the dedication will accommodate future roadway improvements along Vineyard Street.

Your Committee voted to recommend adoption of the proposed resolution and filing of the communication.
