Chair and Members:

Your Public Works and Traffic Committee, having met on June 3, 2004, makes reference to County Communication No. 04-14, from the Director of Public Works and Environmental Management, transmitting a proposed resolution entitled "ACCEPTING DEDICATION OF A ROAD WIDENING LOT FOR THE KENOLIO MAUKA SUBDIVISION, PURSUANT TO SECTION 3.44.015, MAUI COUNTY CODE".

The purpose of the proposed resolution is to accept the dedication of road widening Lot 15, consisting of approximately 1,882 square feet along Kenolio Road in Kihei.

At its meeting, your Committee met with the Director of Public Works and Environmental Management and a Deputy Corporation Counsel.

There was no public testimony.

The Director informed your Committee that the dedication of the road widening lot was necessary to comply with subdivision requirements. He further informed your Committee that all necessary improvements have been made to the subject property. He indicated that developers have the option to either construct improvements that are required as conditions of subdivision approval at a later date by securing a bond, or construct improvements prior to final subdivision approval. In this case, the developers have chosen to construct the improvements. He noted that the road widening lot is approximately 10 feet wide by 188 feet long.

Your Committee voted to recommend adoption of the proposed resolution and filing of the communication.
