AUTHORITY IN GRANTING APPROVAL FOR UTILITY POLES

DESCRIPTION:

The Committee is in receipt of the following:

1. County Communication No. 02-211, from Councilmember Michael J. Molina, transmitting Resolution No. 00-100, entitled "AUTHORIZING DESIGNATION OF THE DIRECTOR OF PUBLIC WORKS AND WASTE MANAGEMENT AS AUTHORIZED REPRESENTATIVE TO IMPLEMENT CHAPTER 12.16, MAUI COUNTY CODE", adopted on August 4, 2000. The purpose of the resolution is to authorize the Director to grant approval for the installation of utility poles.
2. A proposed resolution, introduced by the Committee Chair, entitled "DESIGNATING THE DIRECTOR OF PUBLIC WORKS AND ENVIRONMENTAL MANAGEMENT AS THE AUTHORIZED REPRESENTATIVE TO GRANT PERMISSION TO INSTALL UTILITY POLES PURSUANT TO CHAPTER 12.16, MAUI COUNTY CODE". The purpose of the proposed resolution is to grant the Director of Public Works and Environmental Management authority to approve the placement of utility poles within County rights-of-way.
