PROPOSED BILL AMENDING CHAPTER 10.48, MAUI COUNTY CODE, PERTAINING TO STOPPING, STANDING AND PARKING (RESTRICTING PARKING ON BOTH SIDES OF SOUTH KIHEI ROAD FROM OKOLANI DRIVE TO THE END OF ITS CUL-DE-SAC AT THE KEAWEKAPU BEACH PARK LOT)

DESCRIPTION:

The Committee is in receipt of County Communication No. 03-33, from the Director of Public Works and Environmental Management, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE TO AMEND CHAPTER 10.48, MAUI COUNTY CODE, PERTAINING TO STOPPING, STANDING AND PARKING". The purpose of the proposed bill is to restrict parking along both sides of South Kihei Road from its intersection with Okolani Drive to the end of its cul-de-sac at the Keawekapu Beach Park lot.

STATUS:

The Committee may consider whether to recommend passage of the proposed bill on first reading, with or without revisions. The Committee may consider other related action, including the possible filing of County Communication No. 03-33.

PWT-17 ON-STREET PARKING LIMITS IN THE WAILUKU DISTRICT

DESCRIPTION: The Committee is in receipt of County Communication No. 03-44, from the Director of Public Works and Environmental Management, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE TO AMEND CHAPTER 10.48, MAUI COUNTY CODE, PERTAINING TO ON-STREET PARKING LIMITS IN THE WAILUKU DISTRICT". The purpose of the proposed bill is to establish three-hour parking for six marked parking stalls along the west side of South Market Street, from Palua Street to Pakolu Street.

STATUS: The Committee may consider whether to recommend passage of the proposed bill on first reading, with or without revisions. The Committee may consider other related action, including the possible filing of County Communication No. 03-44.
