MAUI'S TRAFFIC SITUATION

DESCRIPTION:

The Committee is in receipt of the following:

1. County Communication No. 01-85, from Councilmember Michael J. Molina, requesting a comprehensive discussion of Maui's traffic situation and transmitting a *Honolulu Advertiser* article entitled "Frightening traffic mars Maui" (Feb. 2, 2001); and
2. County Communication No. 03-43, from Councilmember Jo Anne Johnson, transmitting a letter from a constituent relating to traffic impacts on Hana Highway and certain adjacent residential streets in the Paia-Spreckelsville area.

STATUS:

The Committee will receive presentations from various State, County, and private representatives regarding potential traffic-reduction improvements for Maui roadways. The Committee may consider whether to recommend any legislative action. The Committee may also consider other related action, including the possible filing of County Communication Nos. 01-85 and 03-43.
