### RENAMING A PORTION OF OLD MAKENA ROAD AKA MAKENA-KEONEOIO ROAD

#### DESCRIPTION:

The Committee is in receipt of the following:

1. County Communication No. 01-117, from the Director of Public Works and Waste Management, relating to the Commission on Naming Streets, Parks and Facilities' recommendation to deny a request to rename a portion of Old Makena Road, aka Makena-Keoneoio Road, as Kukahiko Road; and
2. Correspondence dated September 10, 2003, from the Department of the Corporation Counsel, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING CHAPTER 12.36, MAUI COUNTY CODE, TO RENAME A PORTION OF MAKENA ROAD AS KUKAHIKO PLACE". The purpose of the proposed bill is to rename a portion of Makena Road that intersects with the southern terminus of Honoiki Street extending north to Makena Alanui Road and south to a cul-de-sac.

**PWT-6                    PROPOSED BILL AMENDING CHAPTER 10.48, MAUI COUNTY CODE, PERTAINING TO STOPPING, STANDING AND PARKING (PARKING PROHIBITIONS ON SOUTH KIHEI ROAD)**

**DESCRIPTION:** The Committee is in receipt of the following:

1. County Communication No. 03-33, from the Director of Public Works and Environmental Management, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE TO AMEND CHAPTER 10.48, MAUI COUNTY CODE, PERTAINING TO STOPPING, STANDING AND PARKING". The purpose of the proposed bill is to restrict parking along both sides of South Kihei Road from Okolani Drive to the cul-de-sac at Keawekapu Beach Park; and
2. Correspondence dated September 10, 2003, from the Director of Public Works and Environmental Management, transmitting a revised proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING CHAPTER 10.48 OF THE MAUI COUNTY CODE, PERTAINING TO STOPPING, STANDING AND PARKING". The purpose of the revised proposed bill is to prohibit parking in the following areas: a) on the makai side of South Kihei Road from Okolani Drive to the cul-de-sac at Keawekapu Beach Park; b) on the mauka side of South Kihei Road from the cul-de-sac at Keawekapu Beach Park to the driveway of Wailea Ekahi condominiums from 10:00 p.m. to 7:00 a.m.; and c) on the mauka side of South Kihei Road from the driveway of Wailea Ekahi condominiums to Okolani Drive.

**STATUS:** The Committee may consider whether to recommend passage of either of the proposed bills on first reading, with or without revisions. The Committee may consider other related action, including the possible filing of County Communication No. 03-33.

**PWT-27                    ACCEPTING DEDICATION OF ROAD WIDENING LOT FOR THE VINEYARD STREET ROAD WIDENING SUBDIVISION (WAILUKU)**

**DESCRIPTION:** The Committee is in receipt of County Communication No. 03-215, from the Director of Public Works and Environmental Management, transmitting a proposed resolution entitled "ACCEPTING DEDICATION OF A ROAD WIDENING LOT FOR THE VINEYARD STREET ROAD WIDENING SUBDIVISION, PURSUANT TO SECTION 3.44.015, MAUI COUNTY CODE". The purpose of the proposed resolution is to accept dedication of road widening Lot 2, located at the northwest corner of the intersection of Vineyard and North Market Streets in Wailuku.
