PERFORMANCE MEASURES

DESCRIPTION:

The Committee is in receipt of County Communication No. 03-149, from the Chair of the Budget and Finance Committee, transmitting the matter of developing performance measures for departments and agencies under the purview of the Public Works and Traffic Committee.

STATUS:

The Committee has requested additional information from the Department of Public Works and Environmental Management relating to the establishment of baseline data, shared staffing, customer service and satisfaction, and a prioritization system for certain projects.
