**PWT-20            AUTHORIZING MAUI ELECTRIC COMPANY, LIMITED, TO REPLACE AND INSTALL UTILITY POLES ON LOWER MAIN STREET, WAIALE ROAD, OIHANA STREET, AND NAKOA DRIVE, WAILUKU, MAUI**

**DESCRIPTION:**     The Committee is in receipt of County Communication No. 03-236, from the Director of Public Works and Environmental Management, transmitting a proposed resolution entitled “AUTHORIZING MAUI ELECTRIC COMPANY, LIMITED, TO REPLACE AND INSTALL UTILITY POLES ON LOWER MAIN STREET, WAIALE ROAD, OIHANA STREET, AND NAKOA DRIVE, WAILUKU, MAUI”. The purpose of the proposed resolution is to authorize the replacement of 21 existing wooden utility poles with 20 steel utility poles and 1 wooden utility pole ranging in height from 49 feet to 94 feet, along various roadways in Wailuku.

**STATUS:**            The Committee may consider whether to recommend adoption of the proposed resolution, with or without revisions. The Committee may consider the possible filing of County Communication No. 03-236 and other related action.
