WORK EXEMPT FROM PERMIT (TEMPORARY TENTS)

DESCRIPTION:

The Committee is in receipt of County Communication No. 04-68, from Councilmember Danny Mateo, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING SECTION 16.26.106.2, MAUI COUNTY CODE, PERTAINING TO WORK EXEMPT FROM PERMIT". The purpose of the proposed bill is to exempt from building permit requirements the installation of temporary tents for the following: 1) events sponsored by non-profit organizations; and 2) events in County Parks and Recreation facilities that continue no more than 72 hours.

STATUS:

The Committee may consider whether to recommend passage of the proposed bill on first reading, with or without revisions. The Committee may also consider the possible filing of County Communication No. 04-68 and other related action.

PWT-21 MOLOKAI LANDFILL
