TIME-RESTRICTED PARKING ON BALDWIN AVENUE (PAIA)

DESCRIPTION:

The Committee is in receipt of County Communication No. 04-183, from Councilmember Michael Molina, transmitting correspondence from Mary J. Cochran, President, Paia Plantation, Inc., requesting time-restricted parking on Baldwin Avenue in Paia.

STATUS:

The Committee may receive a presentation from the Department of Public Works and Environmental Management, relating to establishing time-restricted parking on Baldwin Avenue in Paia. The Committee may also consider the possible filing of County Communication No. 04-183 and other related action.

PWT-32 WORK EXEMPT FROM PERMIT (TEMPORARY TENTS)

DESCRIPTION: The Committee is in receipt of the following:

1. County Communication No. 04-68, from Councilmember Danny A. Mateo, transmitting a proposed bill relating to building permit requirements for the installation of temporary tents.
2. Correspondence dated October 28, 2004, from the Department of the Corporation Counsel, transmitting a revised proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING SECTION 16.26.106.2, MAUI COUNTY CODE, PERTAINING TO WORK EXEMPT FROM PERMIT". The purpose of the proposed bill is to exempt from building permit requirements the installation of temporary tents for events in County parks and recreational facilities that continue no more than 72 hours.

STATUS: The Committee may consider whether to recommend passage of the revised proposed bill on first reading, with or without revisions. The Committee may also consider the possible filing of County Communication No.04-68 and other related action.
