### **PROPOSED BUDGET FOR FISCAL YEAR 2005 FOR THE COUNTY OF MAUI**

**DESCRIPTION:**

The Committee is in receipt of County Communication No. 03-265, from the Chair of the Budget and Finance Committee, relating to the matter of the proposed budget for Fiscal Year (FY) 2005. Pursuant to the Charter of the County of Maui, Section 9-2.1, the Mayor must transmit his proposed budget for FY 2005 by March 15, 2004.
