## **REVIEWING, REVISING AND ESTABLISHING REAL PROPERTY CLASSIFICATIONS**

### **DESCRIPTION:**

The Committee is in receipt of the following:

1. Miscellaneous Communication, dated May 19, 1999, from the County Clerk, transmitting the matter relating to reviewing, revising and establishing real property classifications (Committee Report No. 99-81, as amended).
2. Correspondence dated August 29, 2002, from the Department of the Corporation Counsel, transmitting a draft bill entitled "A BILL FOR AN ORDINANCE AMENDING SECTION 3.48.465 OF THE MAUI COUNTY CODE RELATING TO REAL PROPERTY TAX EXEMPTIONS FOR TAXPAYERS OVER SIXTY YEARS OF AGE". The purpose of the draft bill is to increase the homeowner exemption for taxpayers over 60 years of age and over 70 years of age by \$10,000 each, to \$90,000 and \$110,000, respectively.

### **STATUS:**

The Committee may consider whether to recommend passage of the draft bill on first reading, with or without revisions. In addition, the Committee may consider whether to recommend
