Chair and Members:

Your Budget and Finance Committee, having met on August 12, 2003, makes reference to County Communication No. 03-64, from the Budget Director, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING APPENDIX A OF THE FISCAL YEAR 2003 BUDGET FOR THE COUNTY OF MAUI AS IT PERTAINS TO THE DEPARTMENT OF POLICE".

The purpose of the proposed bill is to amend Appendix A, Part I, of the Fiscal Year (FY) 2003 Budget, relating to grant revenues, by appropriating \$50,000 in grant funds from the State Department of Transportation for the Local Community Innovative Seat Belt Program and \$7,000 from the State Department of Health for the Enforcement of State Law Prohibiting Alcohol Sales to Minors.

By correspondence dated March 21, 2003, the Budget Director transmitted the following proposed resolutions:

1. "AUTHORIZING THE ACCEPTANCE OF FUNDS FROM THE STATE OF HAWAII, DEPARTMENT OF TRANSPORTATION FOR THE LOCAL COMMUNITY INNOVATIVE SEAT BELT PROGRAM".

The purpose of the proposed resolution is to authorize the acceptance of grant revenue from the State of Hawaii, Department of Transportation for the Local Community Innovative Seat Belt Program.

2. "AUTHORIZING THE ACCEPTANCE OF FUNDS FROM THE STATE OF HAWAII, DEPARTMENT OF HEALTH FOR THE ENFORCEMENT OF STATE LAW PROHIBITING ALCOHOL SALES TO MINORS PROGRAM".
