**A. COMPLAINT AND ACCUSATION NO. 2009-02, PLEA: NO CONTEST**

**In the matter of the accusation against ILG RESTAURANT #1, LLC dba LAHAINA STORE GRILLE & OYSTER BAR, Dispenser General License No. 286, 744 Front Street, Lahaina, Maui, Hawaii.**

Count 1. On March 28, 2008 between the approximate times of 1:00 a.m. and 1:30 a.m., ILG RESTAURANT #1, LLC dba LAHAINA STORE GRILLE & OYSTER BAR, a dispenser general licensee, did, through its employee(s), sell, serve, or furnish liquor to, or allow the consumption of liquor by Nick Tabangcura, who was at the time under the influence of liquor, as defined in Section 281-1 of the Hawaii Revised Statutes and Section 08-101-5 of the Rules of the Liquor Commission, drugs, as defined in Section 08-101-5 of the Rules of the Liquor Commission, or any combination thereof, contrary to Section 281-78(b)(1)(B) of the Hawaii Revised Statutes and Section 08-101-60(b)(1)(B) of the Rules of the Liquor Commission, County of Maui.

**B. COMPLAINT AND ACCUSATION NO. 2009-03, PLEA: NO CONTEST**

**In the matter of the accusation against KEAWEKAPU LLC dba ZACK'S DELI AND GENERAL STORE, Retail General License No. 161, 2960 South Kihei Road, Kihei, Maui, Hawaii.**

Count 1. On May 29, 2008 at approximately 7:40 p.m., KEAWEKAPU LLC dba ZACK'S DELI AND GENERAL STORE, a retail general licensee, did, through its employee, sell or furnish liquor to Scott Finch, who was at the time under the influence of liquor, as defined in Section 281-1 of the Hawaii Revised Statutes and Section 08-101-5 of the Rules of the Liquor Commission, drugs, as defined in Section 08-101-5 of the Rules of the Liquor Commission, or any combination thereof, contrary to Section 281-78(b)(1)(B) of the

Hawaii Revised Statutes and Section 08-101-60(b)(1)(B) of the Rules of the Liquor Commission, County of Maui.

**C. COMPLAINT AND ACCUSATION NO. 2009-04, PLEA: NO CONTEST**

**In the matter of the accusation against KEAWEKAPU LLC dba ZACK'S DELI AND GENERAL STORE, Retail General License No. 161, 2960 South Kihei Road, Kihei, Maui, Hawaii.**

Count 1. On May 29, 2008 at approximately 7:35 p.m., KEAWEKAPU LLC dba ZACK'S DELI AND GENERAL STORE, a retail general licensee, did, through its employee, sell or furnish liquor to a minor, as defined in Section 281-1 of the Hawaii Revised Statutes and Section 08-101-5 of the Rules of the Liquor Commission, contrary to Section 281-78(b)(1)(A) of the Hawaii Revised Statutes and Section 08-101-60(b)(1)(A) of the Rules of the Liquor Commission, County of Maui.

**D. COMPLAINT AND ACCUSATION NO. 2009-05, PLEA: NO CONTEST**

**In the matter of the accusation against F & K CORPORATION dba SOUP NUTZ & JAVA JAZZ, Dispenser General License No. 123, 3350 Lower Honoapiilani Road, Space 203 & 204, Honokowai, Maui, Hawaii.**

Count 1. On May 30, 2008 at approximately 10:58 p.m., F & K CORPORATION dba SOUP NUTZ & JAVA JAZZ, a dispenser general licensee, did, through its employee, sell, serve, or furnish liquor to a minor, as defined in Section 281-1 of the Hawaii Revised Statutes and Section 08-101-5 of the Rules of the Liquor Commission, contrary to Section 281-78(b)(1)(A) of the Hawaii Revised Statutes and Section 08-101-60(b)(1)(A) of the Rules of the Liquor Commission, County of Maui.

**E. COMPLAINT AND ACCUSATION NO. 2009-06, PLEA: NO CONTEST**

**In the matter of the accusation against 888, INC. dba LONGHI'S, Restaurant General License No. 226, 888 Front Street, Lahaina, Maui, Hawaii.**

Count 1. On May 31, 2008 at approximately 1:03 a.m., 888, INC. dba LONGHI'S, a restaurant general licensee, did, through its employee, sell, serve, or furnish liquor to a minor, as defined in Section 281-1 of the Hawaii Revised Statutes and Section 08-101-5 of the Rules of the Liquor Commission, contrary to Section 281-78(b)(1)(A) of the Hawaii Revised Statutes and Section 08-101-60(b)(1)(A) of the Rules of the Liquor Commission, County of Maui.
