COW-1(5) SETTLEMENT AUTHORIZATION OF CLAIMS AND LAWSUITS (MICHAEL KAHO`OHANO HANO V. COUNTY OF MAUI, CIVIL NO. CV02-00296 HG/BMK)

DESCRIPTION: The Committee is in receipt of correspondence dated October 27, 2004, from the Department of the Corporation Counsel, requesting consideration of a proposed resolution entitled "AUTHORIZING SETTLEMENT OF MICHAEL KAHO`OHANO HANO vs. COUNTY OF MAUI CIVIL NO. CV02-00296 HG/BMK". The complaint alleges violations of the Fair Labor Standards Act. The purpose of the proposed resolution is to authorize settlement of the case, superseding Resolution No. 04-149.

STATUS: The Council provided initial settlement authority in this case by Resolution No. 04-139, which was subsequently superseded by Resolution No. 04-149. The Committee may consider whether to recommend adoption of the proposed resolution, with or without revisions. The Committee may also consider other related action.

NOTE: With reference to this agenda item, one or more executive meetings pursuant to Section 92-5(a)(4), Hawaii Revised Statutes, are anticipated to consult with legal counsel on questions and issues pertaining to the powers, duties, privileges, immunities, and liabilities of the County, the Council, and the Committee.
