Chair and Members:

Your Committee of the Whole, having met on March 15, 2004, makes reference to County Communication No. 03-19, from the Council Chair, regarding the settlement of claims and lawsuits.

Your Committee is in receipt of correspondence dated February 11, 2004, from the Department of the Corporation Counsel, requesting consideration of the possible settlement of Marvin Miles v. County of Maui, Case No. 7-03-00900. Attached to the request is a proposed resolution entitled "AUTHORIZING SETTLEMENT OF MARVIN MILES VS. COUNTY OF MAUI, CASE NO. 7-03-00900". The purpose of the proposed resolution is to authorize the Department of the Corporation Counsel to settle the case.

Your Committee notes that the claim alleges work-related injuries to Marvin Miles's left knee on April 2, 2003.

At its meeting, your Committee met with the Deputy Chief of Police; the Risk Manager, Department of Finance; and a Deputy Corporation Counsel.

There was no public testimony. The Deputy Corporation Counsel provided a brief overview of the case, informing your Committee that the injuries allegedly occurred while Mr. Miles was attending defense tactics training with the Department of Police, and requested the opportunity to discuss the matter in an executive meeting.

Your Committee voted to convene an executive meeting for the purpose of consulting with legal counsel on liability issues in the matter, pursuant to Section 92-5(a)(4), Hawaii Revised Statutes.

At its executive meeting, your Committee met with the Deputy Chief of Police; the Risk Manager, Department of Finance; and a Deputy Corporation Counsel.
