Chair and Members:

Your Policy Committee, having met on December 2, 2008, makes reference to County Communication No. 08-265, from the Chief of Police, transmitting a proposed resolution entitled "AUTHORIZING ACCEPTANCE OF DONATION FROM THE ROTARY CLUB OF LAHAINA SUNRISE, A NONPROFIT ORGANIZATION, TO THE COUNTY OF MAUI, DEPARTMENT OF POLICE, PURSUANT TO CHAPTER 3.56, MAUI COUNTY CODE".

The purpose of the proposed resolution is to authorize the acceptance of a donation from the Rotary Club of Lahaina Sunrise to the Department of Police of a brand new Onsite 200 Radar Speed Dolly, approximately valued at \$4,000.

At its meeting, your Committee met with a Police Captain, Department of Police; and a Deputy Corporation Counsel.

There was no public testimony.

The Police Captain explained that the speed dolly is narrower than the speed trailers currently used throughout the County to inform drivers of their current speed, and useful in the narrow streets of Lahaina. The new speed dolly can also track the speed of passing cars and provide reports on the changes in speed over time.

Your Committee thanked the Rotary Club of Lahaina Sunrise for the donation.

Your Committee voted to recommend adoption of the proposed resolution and filing of the communication.


WHEREAS, Chapter 3.56, Maui County Code, authorizes the Council to accept gifts and donations on behalf of the County; now, therefore,
