**HHS-1 ESTABLISHMENT OF DEADLINES FOR CHANGE IN ZONING (CONDITIONAL ZONING) APPLICATIONS WITH AFFORDABLE HOUSING CONDITIONS TO REQUIRE THE APPLICANT TO DEVELOP AFFORDABLE HOUSING WITHIN A SPECIFIC TIME PERIOD**

**DESCRIPTION:** The Committee is in receipt of a Miscellaneous Communication, dated May 21, 2001 from the County Clerk referring the matter relating to establishing deadlines for change in zoning (conditional zoning) applications with affordable housing conditions to require the applicant to develop affordable housing within a specific time period.

**STATUS:** The Committee may consider whether to recommend any legislative action. The Committee may also consider other related action, including the possible filing of the Miscellaneous Communication.
