PA-7 NATIONAL PARKS SERVICE'S PLAN TO ACQUIRE NU`U RANCH, KAUPO, MAUI HAWAI`I FOR EXPANSION OF HALEAKALA NATIONAL PARK

DESCRIPTION: The Committee is in receipt of a Miscellaneous Communication, dated August 20, 2003, from the County Clerk, referring the matter relating to the National Parks Service's plan to acquire Nu`u Ranch for expansion of Haleakala National Park. On August 19, 2003, the Council adopted Resolution No. 03-131, entitled "SUPPORTING THE NATIONAL PARK SERVICE'S PLAN TO ACQUIRE NU`U RANCH, KAUPO, MAUI, HAWAI`I, FOR EXPANSION OF HALEAKALA NATIONAL PARK".
