PA-1 RELATING TO PARK DEDICATIONS, SECTION 18.16.320 OF THE MAUI COUNTY CODE

DESCRIPTION: The Committee is in receipt of the following:

1. County Communication No. 97-328, from Councilmember Wayne K. Nishiki, relating to the effectiveness of Section 18.16.320, Maui County Code, regarding park dedications.
2. Correspondence dated October 30, 2003, from the Committee Chair, transmitting a draft bill entitled "A BILL FOR AN ORDINANCE RELATING TO PROPERTY VALUATION FOR PAYMENTS IN LIEU OF PARK DEDICATIONS". The purpose of the draft bill is to establish that the "certified market value real property appraisal" shall determine a property's valuation for purposes of calculating required payments in lieu of park dedications.

STATUS: The Committee may consider whether to recommend passage of the draft bill on first reading, with or without revisions. The Committee may also consider the possible filing of County Communication No. 97-328.

**PA-12 APPEALS PROCESS FOR CHAPTER 5.24, MAUI COUNTY CODE,
PERTAINING TO OCEAN RECREATIONAL ACTIVITY BUSINESS
PERMITS**

- DESCRIPTION:** The Committee is in receipt of the following:
1. Miscellaneous Communication, dated September 23, 2003, from the County Clerk, relating to an appeals process for Chapter 5.24, Ocean Recreational Activity Business Permits, in the Maui County Code.
 2. Correspondence dated October 30, 2003, from the Committee Chair, transmitting a draft bill entitled "A BILL FOR AN ORDINANCE TO AMEND CHAPTER 5.24, MAUI COUNTY CODE, TO AUTHORIZE APPEALS RELATING TO OCEAN RECREATIONAL ACTIVITY BUSINESS PERMITS". The purpose of the draft bill is to amend Chapter 5.24 to authorize appeals of decisions by the Director of Finance relating to ocean recreational activity business permits.
