PLU-19 LAND-USE DEFINITIONS (OPEN SPACE ZONING DISTRICT ORDINANCE)

DESCRIPTION: By County Communication No. 02-114, the Planning Director transmitted a draft bill entitled "A BILL FOR AN ORDINANCE ESTABLISHING OPEN SPACE ZONING DISTRICTS IN TITLE 19 OF THE MAUI COUNTY CODE". The purpose of the draft bill is to establish Open Space zoning.

STATUS: The Committee may consider whether to recommend passage of the draft bill on first reading, with or without revisions. The Committee may consider other related action, including the possible filing of County Communication No. 02-114.
