GRANT FUNDS FROM STATE DEPARTMENT OF TRANSPORTATION; AND AMENDING FY 2005 BUDGET, OFFICE OF THE MAYOR (SAFE COMMUNITY OF MAUI'S SHATTERED DREAMS PROJECT)

DESCRIPTION:

The Committee is in receipt of County Communication No. 05-17, from the Budget Director, transmitting the following:
