Your Water Resources Committee, having met on September 17, 2003, makes reference to County Communication No. 03-217, from the Director of Water Supply, transmitting a proposed resolution entitled "ACCEPTING DEDICATION OF A WATERLINE EASEMENT FOR THE MALAIHI AG SUBDIVISION PROJECT PURSUANT TO SECTION 3.44.015, MAUI COUNTY CODE".

The purpose of the proposed resolution is to accept the dedication of a waterline easement for the Malaihi Ag Subdivision in Waiehu.

At its meeting, your Committee met with the Director of Water Supply, a Deputy Corporation Counsel, and Gary Zakian of Koolau Cattle Company, LLC.

Your Committee received testimony from Mr. Zakian requesting adoption of the proposed resolution.

The Director of Water Supply confirmed the Department of Water Supply's support of the proposed easement.

Your Committee discussed the agricultural use of the property, proposed lot prices, compliance with applicable regulations, and water rates.

Your Committee voted to recommend adoption of the proposed resolution and filing of the communication.
