**BF-55            WAILUKU REDEVELOPMENT AREA REAL PROPERTY TAX EXEMPTION**

**DESCRIPTION:**    The Committee is in receipt of County Communication No. 05-341, from the Economic Development Coordinator, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING CHAPTER 3.48, MAUI COUNTY CODE, PERTAINING TO REAL PROPERTY TAX AND THE WAILUKU REDEVELOPMENT AREA". The purpose of the proposed bill is to provide tax incentives to the Wailuku Redevelopment Area.
