Chair and Members:

Your Committee of the Whole, having met on June 14, 2005, makes reference to County Communication No. 05-24, from the Council Chair, regarding the settlement of claims and lawsuits.

Your Committee is in receipt of correspondence dated May 12, 2005, from the Department of the Corporation Counsel, requesting consideration of the possible settlement of Calvin Rita v. County of Maui, Case No. 7-02-01104. Attached to the request is a proposed resolution entitled "AUTHORIZING SETTLEMENT OF CALVIN RITA V. COUNTY OF MAUI, CASE NO. 7-02-01104". The purpose of the proposed resolution is to authorize the Department of the Corporation Counsel to settle the case.

Your Committee notes that this case relates to work-related injuries sustained by Calvin Rita, a County employee, on April 19, 2002.

At its meeting, your Committee met with the Wastewater Reclamation Division Chief from the Department of Public Works and Environmental Management, the Corporation Counsel, and a Deputy Corporation Counsel.

There was no public testimony.

The Deputy Corporation Counsel provided a brief overview of the case and requested the opportunity to discuss the matter in an executive meeting.

Your Committee voted to convene an executive meeting for the purpose of consulting with legal counsel on liability issues in the matter, pursuant to Section 92-5(a)(4), Hawaii Revised Statutes.

At its executive meeting, your Committee met with the Wastewater Reclamation Division Chief from the Department of Public Works and Environmental Management, the Corporation Counsel, and a Deputy Corporation Counsel.
