## Chair and Members:

Your Committee of the Whole, having met on June 28, 2005, makes reference to County Communication No. 05-85, from the Mayor, transmitting a proposed resolution entitled, "ACCEPTING DEDICATION OF REAL PROPERTY SITUATE AT KIHEI, WAILUKU, MAUI, HAWAII, FROM THE STATE OF HAWAII PURSUANT TO SECTION 3.44.015, MAUI COUNTY CODE".

The purpose of the proposed resolution is to accept the dedication of land (TMK: (2) 3-9-07:003) comprised of approximately 0.398 acres and located in Kihei, Maui, for a Veterans Center and community support activities, as provided for by State Executive Order No. 4087.

At its meeting, your Committee met with an Executive Assistant to the Mayor and a Deputy Corporation Counsel.

Your Committee received public testimony in support of the proposed resolution from one person representing the Veterans of Foreign Wars (VFW) of the United States. This person also provided written testimony and copies of photographs of the subject property.

Your Committee received a brief overview from the Executive Assistant who indicated that the Administration will seek to have the Council approve a 20-year lease to the VFW for the property.

Your Committee discussed the fees charged by the VFW for the use of the existing facilities. The testifier indicated that nonprofit groups are asked for a small donation to cover the costs of electricity, water, and maintenance, and commercial users are charged \$200 per day.

Your Committee discussed the hard work the VFW has put into maintaining the subject property as well as a desire not to see the venue used as a site for extravagant weddings.
